Part B. Free Summary of CV (Max. of 3.500 characters, including spaces)

Development of the career of Geography and History at the Autonomous University of Madrid (1989-1993) and the Bachelor's Degree (1994, Extraordinary Degree Award). During the Grade he obtained, in competitive competition, an Erasmus Scholarship at the Università degli Studi di Pisa. Third Cycle Scholar from the Department of Prehistory and Archeology of the UAM, and later a Predoctoral Scholar for 4 years of the Ministry, which allowed the defense in 1997 of his Doctoral Thesis (Extraordinary Doctorate Award). Postdoctoral Fellow of the Community of Madrid until 1999, date in which he joined as Associate Professor in the Area of Archeology of the Department of History, Geography and Philosophy of the University of Cádiz. During these years, he combined teaching and university research with the free exercise of the profession as an archaeologist, a situation that was maintained until 2002, in which he won an opposition through public competition to the professors of University, a position he has held in property until November 2017, when he has taken office as University Full Professor.

In the university institution of Cadiz he has actively participated in the management of his institution: Coordinator of the Area of Archaeology of the Department of History, Geography and Philosophy of the University of Cádiz (2002-2006, 2013-2017); Academic Secretary of the Department of History, Geography and Philosophy (2009 - March 2014); Since 2013 he has joined management tasks within the International Excellence Campus of the Sea - CEIMAR (Coordinator of the Doctoral Program in Maritime History and Archaeology of the EIDEMAR Doctoral School from 2013 to the present, and Academic Secretary of the School since 2014 until 2017).

The research lines are focused on Roman and Late Roman Archaeology, Economic History of Antiquity, Roman ceramics (amphoras, lamps and study of ancient pottery) and Fishing and canning industry in Antiquity, and constitute 720 publications of diverse nature. Author of 34 monographs, of which 8 are own and 26 as scientific editor, edited by two Spanish universities (UCA and UAM), by the CSIC, the Autonomous City of Ceuta-Institute of Ceuta Studies, the Junta de Andalucía, the Municipalities of Los Barrios, Salobreña and San Fernando and by private commercial publishers (Archaeopress...). One of the books has been published by the Government of Morocco and two in the British Archaeological Reports in Oxford. He has written about 175 book chapters in monographs, tributes or catalogues of exhibitions. He is the author of more than 70 articles in Spanish journals, including those with the most prestige in the field and 60 articles in international journals. He has made more than 50 contributions published in International Congresses and more than 50 in National Congresses, having participated in more than one hundred scientific meetings of diverse nature. The rest include minor publications, including prologues, chronicles and book introductions, reviews, exhibition catalogs or dissemination articles (the general list is available by combining the profile of the researcher at academia.edu, the data in Dialnet, searching by author and in the Spanish Ministry general CV template).
